### Section 2 Hazards Identification

**Classification of the Mixture:** Clear colorless liquid. Characteristic odor.

**Most Important Hazards:** Highly flammable liquid and vapor. Causes skin and eye irritation. May cause drowsiness and dizziness.

**Precautionary Statements:**

Keep away from heat/sparks/open flames/hot surfaces. - No smoking.

## Section 4 First Aid Measures

**Eyes:** Rinse cautiously with water for several minutes. Remove contact lenses, if present and easy to do. If redness, burning, blurred vision or irritation persists, transport to nearest medical facility for additional treatment.

**Skin:** Flush skin with water, wash with soap and water. If irritation occurs, get medical attention. Remove contaminated clothing. Do not reuse clothing until cleaned. If material is injected under the skin, transport to the nearest medical facility for additional treatment. ### Special firefighting measure:

Flammable. Vapors may form explosive mixtures with air. Vapors are heavier than air and may spread along floors. Vapors may travel to areas away from work site before igniting/flashing back to vapor source. Use foam or dry chemical to extinguish fire. Water may be used only to keep surrounding containers cool. Firefighters should wear proper protective equipment and self-contained breathing apparatus with full face piece operated in positive pressure mode.

**Handling and Storage Precautions:** Avoid heat, open flames, including pilot lights, and strong oxidizing agents. Use general ventilation to prevent vapor accumulation. Have appropriate fire extinguishers and spill clean-up equipment in or near storage area.

**Work/Hygienic Practices:** Wash with soap and water before eating, drinking, smoking, applying cosmetics, or using toilet. Launder contaminated clothing before reuse.
